PHYSICAL FITNESS STANDARDS
PRE-EMPLOYMENT TESTING

The Henderson Police Department will require any applicant applying for a sworn position to meet the following physical fitness standards during the course of their consideration for employment with the department. The three tests will be designed to measure the aerobic / cardiovascular fitness, usable upper body strength and core endurance and strength needed to effectively perform duties related to the safety of the public and the officer. Standards required at the time of testing are listed below.

The testing will consist of:

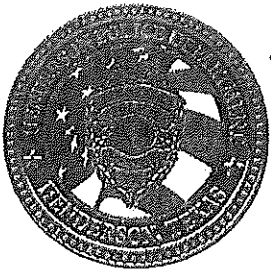
1.5 mile timed run. -- Minimum Time 18:48

Pushups -- Minimum of 10 Completed / No Time Limit

Sit-ups -- Minimum of 16 completed in one (1) minute Completed

These tests will be conducted prior to any offer of employment with the department.

The Henderson Police Department is adding the Concept 2 Rower test as an alternative for the 1.5 mile run for applicant PT testing. To determine your minimum standard for a passing at 35%, visit the [Texas Department of Public Safety website](#) and follow the steps below:

- select your gender and age range then type in your weight
- under the "Desired Results" section, type in "35"
- click "Calculate"
- you must achieve that time or faster to pass the Concept 2 Rower test.

This calculation will be reviewed and the test will be given by the chief or his designee. The test will be given in the Henderson Police department fitness room.
